

Why local government censorship of the press is problematic in a free society and how it affects YOU

Local newspapers are vital for informing communities and holding local governments accountable. When local authorities engage in censorship or restrict access to information, it undermines democratic principles and has direct consequences for the public.

HERE'S WHY LOCAL GOVERNMENT CENSORSHIP OF THE PRESS IS PARTICULARLY PROBLEMATIC:

FREEDOM OF THE PRESS

Press freedom is fundamental to a democratic society.

Local newspapers must be able to report on public affairs without interference or restriction. Censorship blocks journalists from fulfilling their role of holding local government accountable, weakening democratic checks and balances.

SELECTIVE TRANSPARENCY

Censorship allows local governments to control the narrative by selectively sharing information or only communicating with media outlets that offer more favourable coverage.

This is a dangerous trend, as it undermines the principle of equal access to information for all media outlets and could lead to biased or incomplete reporting. The public relies on local newspapers to keep them informed about how their council is spending money, managing services, and handling local issues. When a local government stops communicating with certain newspapers the public may not have access to essential information about everyday services such as roadworks, rubbish collection, libraries, or sports centres. Without open reporting, residents are left uninformed about decisions affecting their daily lives.

PUBLIC ACCOUNTABILITY

A free press ensures that local authorities remain accountable to their communities.

When local governments censor information, the public cannot effectively scrutinise their actions, eroding trust and transparency. This can lead to poor governance as decisions are made without public awareness or input. The public relies on local newspapers to keep them informed about how their council is spending money, managing services, and handling local issues. By refusing to engage with the White Horse News, the council is potentially preventing important information from reaching residents, weakening their ability to hold their elected representatives to account.

EFFECT ON JOURNALISM

Censorship creates a chilling effect on local journalism, making it harder for reporters to investigate important issues.

This could result in a less scrutinising press environment, where newspapers self-censor to avoid conflicts with public bodies.
